FROM THE SOUTH

Take I-93 to Concord, NH to Exit 13, Manchester Street. Take right off of off ramp; go over the bridge to 1st set of lights. Turn left at the lights onto Old Turnpike Road. Follow Old Turnpike Road to traffic light at the intersection with Airport Road. Go straight ahead on Regional Drive past the Air National Guard Armory and through the intersection with Chennell Drive. At the next set of lights, cross Route 106 and follow signs to Smokey Bear Blvd. Follow to end of the road.

FROM THE NORTH

Take I-93 to Concord, NH to Exit 13, Manchester Street. Take left off of off ramp; go over the bridge to 1st set of lights. Turn left at the lights onto Old Turnpike Road. Follow Old Turnpike Road to traffic light at the intersection with Airport Road. Go straight ahead on Regional Drive past the Air National Guard Armory and through the intersection with Chennell Drive. TWO DAY PROGRAMS

****PLEASE READ THE COMPLETE COURSE DESCRIPTION BEFORE YOU MAKE YOUR SELECTION. COURSE CHANGES WILL NOT BE ACCEPTED ONCE AT UNIVERSITY.****

Rope Rescue Techniques: (Saturday & Sunday)

This program will illustrate the proper methods in tying knots, creating hauling systems and safe rappelling systems. Students will be taught the fundamentals and safety factors involved in fire service rope rescue operations. This class is physically challenging and will involve several practical evolutions involving hauling systems and actual rappelling from various heights. ***Students are required to provide a fire service helmet and CLEAN, full fingered leather type gloves (fire suppression gloves are NOT acceptable) to participate in this program. Maximum 10 students.***

Crime Scene to Court Room: (Saturday & Sunday)

This program will illustrate what it's like for a police detective to take an investigation from the crime scene to the court room for prosecution. Students will be taught the fundamentals for processing a crime scene, collecting evidence, obtaining search and arrest warrants, and then finally presenting a case for prosecution.

Engine Company Operations: (Saturday)

The purpose of this class is to illustrate the proper techniques for efficient engine company operations. Students will have a brief overview of engine company responsibilities and discuss / practice techniques used to complete these tasks. The practical evolutions will consist of proper hand line advancement and placement for effective interior operations including multi-level hose line management. Practical evolutions are very physically challenging and will include the use of live training fires. ***Students MUST BE proficient with the use of Self - Contained Breathing Apparatus to participate in this course. Students will be tested Friday evening to ensure their skill level is adequate for the program. Students are required to provide full protective clothing and self-contained breathing apparatus, including a spare SCBA bottle to participate in this program NO EXCEPTIONS. Maximum 16 students.***

Truck Company Operations: (Sunday)

The purpose of this class is to illustrate the proper techniques for efficient truck company operations. Students will have a brief overview of truck company responsibilities and discuss / practice techniques used to complete these tasks. The practical evolutions will consist of forcible entry, victim search and removal, proper ladder selection, placement, use and ventilation techniques. This program will also cover vehicle extrication. Practical evolutions are physically

challenging and will include working a various heights. ***Students MUST BE proficient with the use of Self - Contained Breathing Apparatus to participate in this course. Students will be tested Friday evening to ensure their skill level is adequate for the program. Students are required to provide full protective clothing and self-contained breathing apparatus, including a spare SCBA bottle to participate in this program NO EXCEPTIONS. Maximum 16 students.***

Fire / Arson Investigation: (Sunday)

This course will discuss the principles, methods and procedures used in the field of fire investigation for determining the origin and cause of fire. Arson laws, ways of detecting the crime of Arson, as well as the collection and preservation of evidence will be covered. ***Protective clothing is not required.***

Leadership in Public Safety: (Saturday)

This program will focus on the fundamentals of leadership and how it is applied in public safety agencies. The course will cover the leadership principles, and the roles and responsibilities of public safety agency supervisors and command staff. Students will be required to participate in group projects and team building exercises during the class.



Basic Firearms: (Saturday)

This program is a basic firearm’s class. The student will be taught the basic mechanics of a firearm, how to hold the weapon, proper stance when firing, firearm safety, and the use of force continuum. The class will also involve time at the firearms range, where students will place what they have learned in the classroom to use.

The lead instructor for this program is retired Sgt. Patrick Poirier from the New Hampshire State Police. Sgt. Poirier is a Master Firearms Instructor and served as the lead firearms instructor and armorer for the New Hampshire Department of Safety until his retirement. Sgt. Poirier is also an instructor for the rifle instructor’s program at West Point. Sgt. Poirier served 23 years with the New Hampshire State Police and served with the United States Army, Special Forces prior to joining the New Hampshire State Police.

Advanced Firearms: (Saturday)

This program is an advanced firearm’s class. The student will review basic firearm safety as well as getting to shoot. Students will work on strong hand weak hand shooting techniques, as well as proper stance (supported and unsupported). This program is sponsored by Sig-Arms of Exeter, New Hampshire. **Students will be required to show proof that they have completed a Basic Firearms class before being allowed to participate in the program.**

ONE DAY PROGRAMS

PLEASE READ THE COMPLETE COURSE DESCRIPTION BEFORE YOU MAKE YOUR SELECTION. COURSE CHANGES WILL NOT BE ACCEPTED ONCE AT UNIVERSITY.

On Duty as Police Officer: (Saturday)

This program is designed to illustrate what a police officer might do on a typical patrol shift. The student will learn police procedures, arrest procedures, motor vehicle stops, as well as other topics. *Students MUST bring appropriate clothing for being outdoors in all weather conditions.*

Officer Survival – Active Shooter: (Sunday)

This program will place the student in real life situations which law enforcement officers might face every day. This program is physically challenging and will involve several practical evolutions. *Students will be required to provide long sleeve, heavy weight shirts, pants, gloves and groin protection. Failure to have required safety equipment will not participate.*

Use of Force in Law Enforcement: (Sunday)

The purpose of this class is to demonstrate how and when non-lethal force is used by today's police officers. Students will learn New Hampshire's laws that govern the use of force by Law Enforcement officers and how the use of force continuum works. This class will include practical sessions involving defensive tactics, batons, OC spray, and a Tazer demonstration. ***Proper clothing required (Long pants, shirt, closed shoes).*** The lead instructors for this program are Corporal Brett Wells, Brentwood Police Department, and Sergeant Jason Larochelle, Fremont Police Department.

University of Exploring Physical Fitness Proficiency Award

Introduction: Open to all Explorers attending the University of Exploring, we are offering this new program to encourage Explorers to maintain a healthy lifestyle and physical fitness. Public Safety officials have become concerned about the degradation of physical fitness in adults interested in becoming law enforcement officers, or fire fighters. These officials recognize how critical physical fitness and a healthy lifestyle are to all public safety professions. The lack of physical fitness and an unhealthy lifestyle leads to a host of performance and health issues that negatively impact the individual, the agency, and the community; not to mention the debilitating financial effect to pension plans caused by avoidable disability claims and health relate insurance costs. This award also helps to fulfill the Life Skills component (“to develop physical and mental fitness”) of the five areas of emphasis for Exploring.

Background: Any number of national studies have shown that a fair portion of adults are not properly focused in regard to their physical fitness and overall health. A lack of physical activity and a disconnect with nutritional knowledge have been noted. As a result, many persons required to perform job entry level physical agility tests have displayed less than stellar scores. These results have not only been found in law enforcement, the fire service, the military, and other career fields. It is not within the scope of this award to physically develop an Explorer to the degree that they might pass any job physical fitness testing. The award is intended to reward those Explorers who exhibit the personal characteristics of practicing healthy lifestyle habits and lifestyle management. The Federal Law Enforcement Training Center (FLETC) and The International Association of Chiefs of Police (IACP) graciously accepted the job of assisting in the creation of the criteria in which any Explorer can achieve success.

Award Concept: FLETC and the IACP developed a physical and cognitive assessment that would challenge Explorers; be non-exclusionary in nature to gender, age, facilities and equipment availability; and be long lasting. This award rewards those Explorers who show a level of understanding of the importance of physical fitness through testing. This award is not created to separate the “most fit” from the “unfit”, it is intended to be a reward for those Explorers engaged in and practicing lifestyle habits which promote physical fitness as a lifelong pursuit. The award has two levels: Fitness Award and Distinguished Fitness Award. The Fitness Award consists of base line achievement that can be accomplished with moderate effort but should require practice of physical form, and reading/studying. The Distinguished Fitness Award consists of greater achievement that may take extra physical preparation, and requires a higher score on the cognitive assessment side.

The program uses (6) assessment tools: Curl- Ups, Push-Ups, 1 Mile Run, Pull-Ups, Flexed-Arm Hang, Shuttle Run.

Testing for this award is open to all Explorers attending, but it is not a required portion of the program, or any of the classes we offer. Each Explorer will be asked if they wish to participate Friday evening, and testing will be conducted both Friday and Saturday nights.
